Chicago Fellowship Of Friends

Dear Friends.

Thirty years ago Marlene and Steve Pedigo, obeying God's guidance, came to Chicago to start a ministry to youth under Young Life, a Christian ministry to teenagers. After a few years, as the teenagers in their program became adults, they wanted to have a church home and asked the Pedigos if they could start a church. The Chicago Fellowship of Friends (CFOF) was born and became a mission project of Friends United Meeting (FUM). At the start of the Pedigos' ministry, 20,000 people were living in an area of a few city blocks comprised of high rise housing in the neighborhood known as Cabrini Green.

As the meeting grew and matured, the decision was made to set off the Chicago Fellowship of Friends as a preparative/monthly meeting under Western Yearly Meeting, while at the same time it would remain a mission under FUM.

The Chicago Fellowship of Friends mission to youth received tremendous support from a great number of friends. Individual Friends, monthly meetings, yearly meetings and other religious groups responded with financial and prayer support. Many people were involved in work camps, improving the conditions of the CFOF building/meetinghouse. People reponded to the call of ministry by serving as interns, staff and volunteers at the Chicago Fellowship of Friends. The mission was directed to youth; however, ministry was also provided to adults including Meeting for Worship, Sunday School, parent groups, the After School program and other activities. The CFOF Advisory/Oversight Board recognizes that the CFOF began as an inner city mission to youth and developed into a companioning monthly meeting.

But Cabrini Green changed with the times. By early 2005, with the closing and razing of housing, there were less than 2,500 people living there, and people continue to move out of the community. The CFOF recognized that it had completed its mission and minuted approval to lay down all of its outreach programs which was accomplished on May 27, 2005. The CFOF building is now for sale, and we anticipate all closing processes will be completed by early fall. The Pedigos have relocated to Plainfield, Indiana to take up their duties as Co-Superintendents of Western Yearly Meeting.

The CFOF ministry is no longer seeking funds to support this inner city outreach ministry. Any additional funding designated for the support of the Fellowship of Friends and/or the Pedigos beyond June, 2005 will be returned to the donors. It is with gratitude that we thank all Friends who have so generously supported this demanding, creative and important ministry. Truly it has been God's work.

We encourage all Friends to remember with joy and satisfaction the significant ministry of the Chicago Fellowship of Friends and to keep all of its members and participants in our prayers as they move through their transitions.

Dale Keen, of LeGrand, died Wednesday, June 22 at Villa Del Sol Care Center in Marshalltown, just 15 days after his 92nd birthday. Dale was an Iowa-born, life-long farmer who enjoyed working with his hands not only in the soil but also in the kitchen baking goodies and in the woodworking shop shaping special creations. Throughout his life, Dale was an important contributor to both LeGrand Friends Church (LFC) and Iowa Yearly Meeting. He served as Clerk of LFC for many years and was Vice Chairman of the Building Committee when the current church building was built in 1951. Dale was one of the original five men who scouted out the land for what is now Camp Quaker Heights. He was one from that committee who saw potential and brought tractors up to start filling in the huge hole that is now the driveway. We can truly say along with the apostle Paul in 2 Timothy 4:7 that Dale "...fought the good fight, ... finished the race, ... [and] ... kept the faith." Dale leaves behind his wife of 59 years, Gertrude Keen, two children, six grandchildren, and 13 great-grandchildren.

Kathryn White Tjossem died unexpectedly in her sleep, April 28, 2005, at the Barthell OES Home in Decorah, Iowa, were she had resided for a few weeks. The daughter of Bernard and Ruth Bryant White, she was a lifelong member of Hesper Friends Meeting and had been active in Christian Education, Hesper Friends Women, and the general life of the Meeting. Services were held Monday, May 2, at Hesper Friends Meeting with pastor Keith Mardock officiating. Burial was in the Hesper Public Cemetery. Kathryn is survived by her husband, Lawrence; her four children, Greg, Judy, Cindy, and Steve, and their families; and three sisters, Theresa Wells, Bernadine Cooper, and Myrna Mardock.

Bessie Alice (Betty) Palmer was born May 2, 1918 in Grinnell, lowa, the daughter of Bert and Susan Whitaker. She was educated in the Grinnell School District, graduating from high school in 1936. Giving With A Gift Annuity

Weldon Troyer is very supportive of the small church-affiliated college where he graduated nearly 45 years ago. He has supported the school with cash donations every year, but what he would really like to do is make a major gift that could have a substantial impact. The problem, he is worried he might need that money in retirement, so he continues to dream of someday making the gift. The good news is that Weldon can use a gift annuity to make his gift today and receive an annual or quarterly cash payment for the rest of his life.

You or you and your spouse can give assets (cash or appreciated assets) to a charity, like Mennonite Foundation, using a gift annuity agreement. Your immediate benefits include: a charitable deduction for a significant part of the gift, a guaranteed fixed payment for the rest of their lives (a portion of the guaranteed payment may be tax free), and the satisfaction of knowing that a ministry or ministries dear to them will benefit at their death with any dollars that remain.

Questions that we hear often include:

minimum gift of \$5,000.

What assets can be given to this type of agreement?
Cash, publicly traded stocks, mutual funds, or any asset that can be turned to investable funds soon after the gift is made are best suited. An asset that has appreciated in value can be most beneficial as the person making the gift defers the payment of tax on the gain as well as receives a charitable deduction. Gift annuity agreements with Mennonite Foundation may be started with a

How is the payment to me/us determined? It is determined based on the age of the person or persons who are to receive the payment. The older you are, the higher the interest rate will be. Current interest rates are very attractive compared to a typical bank deposit.

How much will the charity receive at my/our passing?

Charities normally receive between 50 percent and 70 percent of the original gift. The agreement considers that part of the amount gifted will be paid back to you as fixed payments. Should you live long past normal life expectancies, the amount that goes to charity will decrease as the years elapse.

How do my ministries benefit if the agreement is with Mennonite Foundation? Mennonite Foundation serves as a conduit to the ministries you choose to support. Most organizations do not have the means to operate a gift annuity program of their own.

Why does the charity receive the money after I/we are gone? Because there is a promise to pay you for life, the funds are invested in a way to help generate the payment and preserve the value of the original amount gifted.

Every person's financial and family situations are unique. The value placed on gifting to ministries for which you are passionate must be balanced with the desire to take care of your personal and family needs. This balancing happens continually during your life. Using a gift annuity or a series of gift annuities over a number of years can be both a statement of what is important to you from a giving standpoint and can be a way to preserve a cash flow to you.






MEETING MOMENTS
