Life Insurance A Gift to Charity?

You are probably living out your faith in your daily life through caring and sharing. You may be in reasonably good health and have either a modest investment portfolio (retirement or otherwise), a comfortable cash flow from your earnings or retirement income, or both.

Have you considered ways to expand the financial resources you may leave behind? One way may be to take out a life insurance policy with one or more charitable beneficiaries. Making an annual or one-time premium payment to assure the policy is completely paid up can guarantee your charitable legacy to the ministries and missions for which you care. This can be accomplished in a number of ways.

First, you may have an existing policy that could be changed to name charity as a total or partial beneficiary? To change beneficiaries simply contact your agent. You may name the charity as a primary beneficiary to receive the entire benefit, or a percent of the benefit, or as a secondary beneficiary to receive the benefit if the primary beneficiary does not survive you. In this instance the life insurance policy is still owned by you and will be part of your estate valuation, but the amount that is paid to a charity is a reduction to your estate's value.

Second, you may wish to have a charity be the owner of a life insurance policy on your life. In this instance you should contact the charity to inquire of their interest in this type of gift. This works best with new life policies rather than existing policies. When the policy gift is made to the charity, the life insurance company notifies the charity annually when the premium is due. In turn, the charity alerts you to make a charitable contribution to them for the premium amount. Should you be unable to make the premium contribution the policy would lapse. Because the charity usually is not able to pay – or does not make a practice of paying the premium if you are unable, they are sometimes hesitant to receive this type of gift.

One of the services Mennonite Foundation provides for persons considering life insurance as a gifting vehicle is to serve as the charitable owner. Working with an MMA counselor or your insurance agent, you choose the life insurance policy that fits, and then work with Mennonite Foundation to assure the ownership interest is perfected. Premium contributions are made by you to Mennonite Foundation, and you name the charities you want to benefit. Charitable gift recommendations can be modified by you at any time. This type of gift can expand your estate's potential and bless many people served by the ministries you choose!


