What is a Charitable Remainder Trust? By Jeffrey Swartzentruber, CPA Mennonite Foundation Representative Vice President of MMA Trust Company

There are several ways for donors to make gifts to charity but still receive income payments during your lifetime. I presented a breakout session at the August Yearly Meeting that included input on different types of these planned gift agreements.

One type of agreement is a charitable gift annuity. We introduced gift annuities as an idea in the July/August 2005 edition of the Iowa Friend. The major difference between a charitable remainder trust and a gift annuity is that a trust is a separate legal entity, apart from you, the donor, and apart from Mennonite Foundation, the trustee and remainder beneficiary. There are two basic types of Charitable Remainder Trusts. The Charitable Remainder Annuity Trust (CRAT) is one. The CRAT is most similar to a gift annuity in that it is funded with a one-time gift and the payment is a donor-chosen percent of the initial gift amount. This amount is fixed for the life of the CRAT.

The Charitable Remainder Unitrust (CRUT) is the other variation. Within the CRUT there are variations that can provide flexibility to you in your particular situation. This type of trust can accept more than one gift from the donor(s) in its lifetime. The payment is a percentage of the beginning of the year market value of the trust assets. This means the payment is designed to be variable, and the desired outcome is for the payment to potentially increase over the years as the value of the trust assets increase. Setting the payment percentage low enough that the average return of the trust assets exceeds the payment percentage enhances the likelihood of this outcome. When the payment percentage is set higher than expected investment returns, the payment and asset base in the trust decline instead of grow.

Why does the charity receive the money after I/we are gone? Because there is a promise to pay you for life or as long as the trust assets hold, the funds are invested in a way to balance your interest as donor/income beneficiary and preserve a value for your chosen charities who will receive what is left.

You or you & your spouse can give assets (cash or appreciated assets) to a charity, like Mennonite Foundation, using any of the types of charitable remainder trusts. Your immediate benefits include: a charitable deduction for a significant part of the gift, payments for the rest of your lives, and the satisfaction of knowing that a ministry or ministries dear to you will benefit at your death with any dollars that remain. Questions that we hear often include -

What assets can be given to this type of agreement?

Cash, publicly traded stocks, mutual funds, or any asset that can be turned to investable funds soon after the gift is made are best suited. An asset that has appreciated in value can be most beneficial as the person making the gift defers the payment of tax on the gain as well as receiving a charitable deduction. Charitable remainder trusts with Mennonite Foundation may be started with a minimum gift of \$30,000.

How is the payment to me/us determined? Payments are determined by the trust document provisions and stated as a percent of assets. We suggest the payment percentage be set at between 5 percent and 7 percent annually. The IRS minimum percentage is 5 percent. We suggest this range in order to create an environment where the trust assets have a reasonable probability of growth. There may be times when you want to receive a higher payout percentage. We will work with you to achieve your goals with legal parameters and provided you understand the possible outcomes from your choice.

How much will the charity receive at my/our pass-

ing? This depends on the percentage payout chosen and the returns of the trust. A lower payout percentage to you with an investment return in the trust that is higher than the payout percentage will result in a gift that is greater than the original gifted amounts. A payout percentage that is higher than the average return percentage will result in a reduced gift to charity, or no gift to charity.

How do my ministries benefit if the agreement is with Mennonite Foundation? Mennonite Foundation serves as a conduit to the ministries you choose to support. Most organizations do not have the means to serve as trustee of their own charitable trusts. An additional benefit of using Mennonite Foundation as your trustee is knowing that all of the funds in your trust will be invested in ways that are in harmony with your values.

Every person's financial and family situations are unique. The value placed on gifting to ministries for which you are passionate must be balanced with the desire to take care of your personal and family needs. This balancing happens continually during your life. Using a charitable remainder trust can be a statement of what is important to you and a way to preserve a cash flow to you.


